RE: FRANCESCA WATER COMPANY, INC. SECOND REQUEST FOR AN EXTENSION OF TIME TO COMPLY WITH DECISION NO. 63660, DOCKET NO. W-02838A-00-0684 ET. AL.

In Decision No. 63660, the Commission conditioned its approval of the extension of the Certificate of Convenience and Necessity of Francesca Water Company (Francesca) on it submitting a copy of its Pima County Franchise to the Commission within 365 days of the effective date of the Commission's Decision. The authorization for the extension would be considered null and void without further order of the Commission in the event the Company failed to meet this condition within the time specified.

Compliance on this item was due May 4, 2002. Francesca failed to file the franchise within the time specified and the Certificate of Convenience and Necessity was void at that time without further order of the Commission.

On May 23, 2002, Francesca filed a request for an extension of time to comply with the above condition. On June 24, 2002, the Commission issued a Procedural Order that granted an extension of time to November 4, 2002. If the Company files the franchise at that time, the CC&N is reinstated.

On November 1, 2002, Francesca made a second request for an extension of time stating that Pima County had lost its application, and that it had filed a new application with Pima County on September 19, 2002. Francesca has requested a further 90 day extension of time beyond November 4, 2002. Staff has no objections to the request and recommends an extension of time to February 3, 2003 to comply.
