MOTION TO CONSOLIDATE



Staff now moves pursuant to R14-3-109(H) to consolidate the Application of Francesca Water Company for the sale of assets and transfer of its CC&N to Francesca Water Company, Inc. in docket No. W-03945A-00-0788,


