PROCEDURAL ORDER

BY THE COMMISSION:

On September 11, 2000, and October 24, 2000, Francesca Water Co., Inc. ("FWC") filed with the Arizona Corporation Commission ("Commission") an application for a rate increase and an extension of FWC's Certificate of Convenience and Necessity ("CC&N"), respectively.

On November 7, 2000, Commission Staff ("Staff") filed a Motion to Consolidate ("Motion"). No opposition has been filed and accordingly, the Motion should be granted.

IT IS THEREFORE ORDERED that the above-captioned matters are hereby consolidated.

IT IS FURTHER ORDERED that the consolidation is an extraordinary event pursuant to A.A.C. R14-2-103 and accordingly, the time periods for the rate case shall be extended to allow completion of the application for the CC&N extension.
