BY THE COMMISSION:

Having considered the entire record herein and being fully advised in the premises, the
Arizona Corporation Commission ("Commission") finds, concludes, and orders that:

FINDINGS OF FACT

1. On August 25, 2000, in Decision No. 62864, the Commission granted to Network
Access Solutions ("NAS" or "Applicant") a Certificate of Convenience and Necessity ("CC&N")
authorizing it to provide facilities-based and resold intrastate telecommunications services in
Arizona.

2. On July 21, 2003, Applicant filed with the Commission an application to cancel its
Certificate. The application stated that Applicant is no longer providing facilities-based or resold
telecommunications services in Arizona and has no customers.


3. On November 12, 2003, the Commissioner's Utilities Division ("Staff") filed a Staff
Report in this matter.

4. In the Staff Report, Staff verified that Applicant does not service any Arizona
customers and is no longer doing business in Arizona. Staff has indicated there are no open
complaints or inquiries concerning NAS. In addition, Staff stated that there are numerous other
carriers offering services similar to Applicant's in Arizona.

1 IT IS FURTHER ORDERED that Network Access Solutions is no longer authorized to
2 provide facilities based and/or resold interexchange telecommunications services in Arizona and
3 therefore is no longer subject to the requirements of Decision No. 62864.

4 IT IS FURTHER ORDERED that this Decision shall become effective immediately.
