12 **BY THE COMMISSION:**

13 Having considered the entire record herein and being fully advised in the premises, the
14 Arizona Corporation Commission ("Commission") finds, concludes, and orders that:

15 **FINDINGS OF FACT**

16 1. K. Travis Johnson and Marilyn J. Johnson dba Desert Communications ("Applicant")
17 has a Certificate of Convenience and Necessity ("Certificate") to provide customer-owned pay
18 telephone ("COPT") service in the State of Arizona pursuant to Decision No. 59671 (May 15, 1996).

19 2. On May 17, 2002, Applicant filed with Docket Control of the Commission an
20 application for approval of the cancellation of the Certificate, indicating that it no longer provides
21 COPT service in the State of Arizona.

22 3. In Decision No. 55817 (December 10, 1987), the Commission found that COPT
23 providers were public service corporations subject to the jurisdiction of the Commission.

24 4. Decision No. 57797 (April 8, 1992) adopted A.A.C. R14-2-901 through R14-2-909 to
25 regulate COPT providers.

26 5. Decision No. 58535 (February 14, 1994) adopted a Generic Tariff that establishes
27 rates and minimum service standards applicable to COPT service.

28 6. Pursuant to A.R.S. § 40-282, the Commission may issue Decisions regarding COPT

ORDER

IT IS THEREFORE ORDERED that the application of K. Travis Johnson and Marilyn J. Johnson dba Desert Communications for the cancellation of the Certificate of Convenience and Necessity to provide customer-owned pay telephone service shall be, and is hereby, approved.

IT IS FURTHER ORDERED that this Decision shall become effective immediately.
