PROCEDURAL ORDER

BY THE COMMISSION:

On July 13, 2005, Pac-West Telecomm, Inc. ("Pac-West") filed a complaint against Qwest Corporation ("Qwest") alleging that Qwest has failed to comply with certain terms of the parties' interconnection agreement.

On August 16, 2005, the Parties filed a Joint Stipulation for Extension to File Answer and for Briefing Schedule.¹

Pursuant to the Joint Stipulation, Qwest filed its Answer and Counterclaim on August 22, 2005.

The parties are involved in a similar proceeding before the Washington commission, and believe the issues involved in the complaint are primarily legal issues that can be resolved upon expedited briefing and oral argument rather than an evidentiary hearing. The jointly proposed briefing schedule appears reasonable, and is hereby adopted with slight modification as set forth below.

IT IS THEREFORE ORDERED that the parties shall file Simultaneous Opening Briefs on or before September 14, 2005.

IT IS FURTHER ORDERED that the parties shall file simultaneous Response Briefs on or before October 12, 2005.

1 IT IS FURTHER ORDERED that a **Procedural Conference** for the purpose of **Oral**
2 **Argument** shall commence on **October 24, 2005**, at 10:30 a.m. at the Commission's offices, 1200
3 West Washington St., Phoenix, Arizona, 85007.

4 IT IS FURTHER ORDERED that the Ex Parte Rule (A.A.C. R14-3-113-Unauthorized
5 Communications) applies to this proceeding as the matter is now set for public hearing.

6 IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend, or waive
7 any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.


