**MOTION FOR EXTENSION OF TIME TO FILE
AMENDED ASSURED WATER SUPPLY DESIGNATION
IN COMPLIANCE WITH DECISION NO. 67240**

Santa Cruz Water Company, LLC (SCWC) hereby requests an extension of time to file an amended Assured Water Supply Designation in compliance with Decision No. 67240. SCWC requests that the compliance date be extended until the filing date of a similar compliance requirement in Decision No. 67830, which would be May 5, 2006. In support of this motion, SCWC states as follows:

After Decision No. 67240 was issued, SCWC contacted the Arizona Department of Water Resources (ADWR) about an amendment to its Assured Water Supply Designation in connection with the extension area granted by Decision No. 67240. ADWR informed SCWC that its existing Assured Water Supply Designation (and related Physical Availability Demonstration) was sufficient for the SCWC service area even if the extension was included. Therefore, no amendment to the Assured Water Supply Designation was necessary. In effect, the compliance

1 requirement had already been met in the eyes of ADWR – SCWC had a sufficient Assured Water
2 Supply Designation for the extension area granted in Decision No. 67240.

3 Subsequent to Decision No. 67240, SCWC was granted an additional CC&N extension in
4 Decision No. 67830. That Decision also included a compliance requirement to file an amendment
5 to the Assured Water Supply Designation. SCWC has submitted an application for such an
6 amendment. Notice of the application was published in July of 2005 and no objections were
7 submitted to ADWR. SCWC anticipates that the amendment will be issued in the immediate
8 future given the applicable statutory time frame. This amendment will confirm that SCWC has a
9 sufficient Assured Water Supply Designation for both of the extension areas and will be filed with
10 the Commission upon receipt by SCWC.

11 WHEREFORE, SCWC requests that the compliance date for filing an amendment to its
12 Assured Water Supply Designation under Decision No. 67240 be extended to be coterminous with
13 the compliance date for a similar compliance requirement in Decision No. 67830 (i.e. May 5,
14 2006). Alternatively, SCWC requests that the compliance requirement be eliminated because its
15 existing Assured Water Supply Designation was sufficient for the CC&N extension area granted
16 by Decision No. 67240.
