PROCEDURAL ORDER

BY THE COMMISSION:

On September 29, 2000, Morenci Water and Electric Company ("MWE") filed with the Arizona Corporation Commission ("Commission") an application for a change in its Purchase Power Fuel Adjuster Clause ("PPFAC") rate that the Commission approved in Decision No. 61705 (May 13, 1999).

On May 7, 2001, MWE filed a Motion to Withdraw the Application ("Motion"). In its Motion, MWE explained that rather than seeking to adjust its PPFAC as outlined in the application, it will follow the process set forth in Decision No. 61705, and change its PPFAC rate of negative 0.05052 per kWh back to negative 0.01391 per kWh, the rate in place prior to Decision No. 61705.

On May 15, 2001, Commission Staff filed a Response, and had no objection to the Motion provided MWE timely notified its customers that its PPFAC is being changed.

No party has objected to the Motion.

IT IS THEREFORE ORDERED that MWE's application shall be deemed withdrawn and the docket closed upon MWE filing certification with the Utilities Division's Compliance Section, within 30 days of the date of this Procedural Order, that it has notified its customers of the change in its PPFAC rate.
