11 **BY THE COMMISSION:**

12 Having considered the entire record herein and being fully advised in the premises, the
13 Arizona Corporation Commission ("Commission") finds, concludes, and orders that:

14 **FINDINGS OF FACT**

15 1. D & B Leasing Company ("Applicant") has a Certificate of Convenience and
16 Necessity ("Certificate") to provide customer-owned pay telephone ("COPT") service in the State of
17 Arizona pursuant to Decision No. 60156 (April 17, 1997).

18 2. On January 24, 2001, Applicant filed with the Commission an application for approval
19 of the cancellation of the Certificate, indicating that it no longer provides COPT service in the State
20 of Arizona.

21 3. In Decision No. 55817 (December 10, 1987), the Commission found that COPT
22 providers were public service corporations subject to the jurisdiction of the Commission.

23 4. Decision No. 57797 (April 8, 1992) adopted A.A.C. R14-2-901 through R14-2-909 to
24 regulate COPT providers.

25 5. Decision No. 58535 (February 14, 1994) adopted a Generic Tariff that establishes
26 rates and minimum service standards applicable to COPT service.


27 6. Pursuant to A.R.S. § 40-282, the Commission may issue Decisions regarding COPT
28 Certificates without a hearing.

ORDER

IT IS THEREFORE ORDERED that the application of D & B Leasing Company for the cancellation of the Certificate of Convenience and Necessity to provide customer-owned pay telephone service shall be, and is hereby, approved.

IT IS FURTHER ORDERED that this Decision shall become effective immediately.
