PROCEDURAL ORDER

13 **BY THE COMMISSION:**

14 On June 27, 2001, ServiSense.com, Inc. ("ServiSense") submitted to Docket Control of the
15 Arizona Corporation Commission ("Commission") an application for a Certificate of Convenience
16 and Necessity ("Certificate") to provide competitive resold local exchange and interexchange
17 telecommunications services with the State of Arizona.

18 Decision No. 63834 (June 28, 2001) approved the application and required ServiSense to file
19 conforming tariffs within 30 days of the effective date of the Commission's Decision, file proof of a
20 performance bond for a minimum of \$25,000 within 30 days of the effective date of the Decision and
21 notify the Commission when they will begin providing service.

22 On July 30, 2001, ServiSense filed a Request for an Extension of time to Comply with
23 Decision No. 63834..

24 On September 25, 2001, Staff filed a Memorandum stating they have no objection to the
25 request for extension of time.

26 IT IS THEREFORE ORDERED that ServiSense file conforming tariffs, file proof of a
27 performance bond for a minimum of \$25,000 by November 9, 2001 at which time they will also
28 notify the Commission when they will begin providing service in the State of Arizona.
