PROCEDURAL ORDER

BY THE COMMISSION:

On October 25, 2000, Norstar Communications, Inc. d/b/a Business Savings Plan by Norstar Communications ("Norstar" or "Applicant") filed with Docket Control of the Arizona Corporation Commission ("Commission") an application for a Certificate of Convenience and Necessity ("Certificate") to provide competitive resold intrastate telecommunications services, except local exchange service, within the State of Arizona. The Applicant is required to publish notice of its filing in newspapers in all counties where service is to be provided. The record shows that the Applicant has not published notice.

On January 11, 2001, the Commission's Utilities Division Staff ("Staff") filed its Staff Report in this matter.

Pursuant to A.R.S. § 40-282, the Commission may act on an application for a Certificate to provide resold telecommunications services without a hearing, or with a hearing if one is requested by any party.

The time frame for processing this application is July 25, 2001.

Pursuant to Commission rules, the Commission now issues this Procedural Order to govern the preparation and conduct of this proceeding.

IT IS THEREFORE ORDERED that the timeframe for processing the application shall be July 25, 2001.

1 IT IS FURTHER ORDERED that the Applicant shall publish notice, as stated below, in
2 newspapers in every county in Arizona in which Applicant desires to provide service by February 23,
3 2001, and shall file Affidavits of Publication no later than March 16, 2001.

10 Norstar Communications, Inc. d/b/a Business Savings Plan by Norstar
11 Communications ("Applicant") has filed with the Arizona Corporation Commission
12 ("Commission") an application for a Certificate of Convenience and Necessity
13 ("Certificate") to provide resold intrastate telecommunications services in the State of
14 Arizona. Applicant will be required by the Commission to provide this service under the
15 rates and charges and terms and conditions established by the Commission.

16 A.R.S. § 40-282 provides that the Commission may act on an application for a
17 Certificate to provide resold telecommunications services without a hearing, or with a
18 hearing, if one is requested by any party. Applicant or any other party must request a
19 hearing within 21 days from the date of this publication, or the Commission will rule on
20 the application without a hearing.

21 The application, report of the Commission's Utilities Division Staff, and any
22 written exceptions to the Staff Report prepared by the Applicant are available for
23 inspection during regular business hours at the offices of the Commission located at 1200
24 West Washington Street, Phoenix, Arizona 85007, and at Applicant [address].

25 Under appropriate circumstances, interested parties may intervene in the
26 proceedings and participate as a party. Intervention shall be in accordance with A.A.C.
27 R14-3-105, except that all motions to intervene must be filed within 21 days from the
28 date of this publication. You may have the right to intervene in the proceeding, or you
may make a statement for the record. If you have any comments, mail them to:


7 IT IS FURTHER ORDERED that intervention shall be in accordance with A.A.C. R14-3-105
8 except that all motions to intervene must be filed on or before March 16, 2001.

9 IT IS FURTHER ORDERED that Applicant shall file written exceptions, if any, to the Staff
10 Report or a request that a hearing be set by **12 noon** on March 16, 2001.

11 IT IS FURTHER ORDERED that the time periods specified herein shall not be extended
12 pursuant to Rule 6(a) or (e) of the Arizona Rules of Civil Procedure.

13 IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend or waive
14 any portion of this Procedural Order by subsequent Procedural Order or by ruling at hearing.


