PROCEDURAL ORDER

10 **BY THE COMMISSION:**

11 On August 25, 1997, Vista Group International, Inc., ("Applicant" or "Vista") filed with the
12 Arizona Corporation Commission ("Commission") an application for a Certificate of Convenience
13 and Necessity ("Certificate") to provide resold interexchange telecommunications services within the
14 State of Arizona.

15 On October 6, 7, 10, and 31, 1997, Applicant filed affidavits of publication indicating it had
16 published notice of its application for authority to provide resold interexchange services.

17 On January 22, 2001, the Commission's Utilities Division Staff ("Staff") filed its Staff Report
18 in this matter.

19 Pursuant to A.R.S. § 40-282, the Commission may act on an application for a Certificate to
20 provide resold telecommunications services without a hearing, or with a hearing if one is requested
21 by any party.

22 Pursuant to Commission rules, the Commission now issues this Procedural Order to govern
23 the preparation and conduct of this proceeding.

24 IT IS THEREFORE ORDERED that the Applicant shall file with the Commission written
25 exceptions, if any, to the Staff Report and any request for hearing, by May 31, 2001.

26 IT IS FURTHER ORDERED that the time periods specified herein shall not be extended
27 pursuant to Rule 6(a) or (e) of the Arizona Rules of Civil Procedure.

28 IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend or waive

1 any portion of this Procedural Order by subsequent Procedural Order or by ruling at hearing.
