SECTION 4 - RATES AND CHARGES, (CONT'D.)**4.9 Directory Assistance - Maximum Rates**

A Directory Assistance charge applies per intrastate directory assistance calls made from points within the State of Arizona. The Customer may make two (2) requests for a telephone number per call. The Directory Assistance Charge applies regardless of whether the operator is able to supply the requested number. Discounts are not applicable to Directory Assistance Charges. Directory Assistance Charges are not included in usage commitments or computed in any discount calculations.

Per call to directory assistance: \$1.00

4.10 Nickel Line Service- Maximum Rates

Nickel Line Service is offered to residential Customers for originating calls from standard switched lines on a direct dial basis. Nickel Line Service is offered only in conjunction with interstate service to obtain the lower interstate rate. Each call is rated individually and billed in one minute increments after an initial minimum call duration of one minute.

Option 1:

Rate per intrastate minute: \$0.30
Monthly recurring charge: \$5.90

Option 2:

Rate per intrastate minute: \$0.20
Monthly recurring charge: \$9.90

Option 3:

Rate per intrastate minute: \$0.20
Rate per completed intrastate call: \$0.20
Monthly recurring charge: \$5.90
