Dear Bleser:

According to Arizona Corporation Commission ("Commission") records, you are the representative for United Services Telephone, L.L.C. I am writing to inform you that Commission Staff is ready to process your application for a Certificate of Convenience and Necessity ("CC&N") to resell communications services within the State of Arizona and for a determination that services of the company are competitive. However, the consultant listed in your application, Ms. Connie Wightman of Technologies Management, Inc., informs me that you are no longer a client of their company. Also, the telephone numbers listed in your application are no longer in service.

Therefore, the purpose of this letter is to send a final notification, to the last known representative's address on record, to determine if the above referenced company wishes to have its application processed. If so, you must provide the following updated information: the current name of the company, whether the company is doing business and continues to do business in Arizona, accurate names of contact people in the company, and current and accurate company addresses and telephone numbers and e-mail address if available.

All updated information (*i.e.* amendments to the original application) must be mailed within 30 days of this letter to: Docket Control Center, Arizona Corporation Commission, 1200 West Washington, Phoenix, Arizona 85007. An original and 10 copies are required. Please include the company's docket number on all documents. Enclosed is a docket cover sheet and filing instructions for your convenience.

If you no longer wish to have your application processed, a Request to Withdraw form is also enclosed for your convenience. Please complete the form, and send original and 10 copies of the form to the Docket Control Center, with the enclosed Docket Cover Sheet.


If your response is not received in the Docket Control Center by **September 29, 2000**, as the last known representative on record, the pending application will be terminated and the docket administratively closed. **Be advised that the legal consequence of dismissal or**
