ORDER

**BY THE COMMISSION:**

Having considered the entire record herein and being fully advised in the premises, the Commission finds, concludes, and orders that:

FINDINGS OF FACT

1. On February 28, 2001, Novo Networks Metro Services, Inc. ("Applicant" or "Novo") filed with the Commission an application for a Certificate of Convenience and Necessity ("Certificate") to provide competitive resold interexchange telecommunications services within the State of Arizona.

2. In Decision No. 58926 (December 22, 1994), the Commission found that resold telecommunications providers ("resellers") were public service corporations subject to the jurisdiction of the Commission.

3. Applicant is a Delaware corporation, authorized to do business in Arizona since 2000.

4. Applicant is a switchless reseller, which purchases telecommunications services from WorldCom and Global Crossing.

5. On March 20, 2001, the Commission's Utilities Division Staff ("Staff") filed its Staff Report in this matter. In its Staff Report, Staff stated that Novo Networks Metro Services, Inc.

1 provided financial statements for the nine months ending September 30, 2000. These financial  
2 statements list assets of \$207,272,593, equity of \$176,285,259, and a net loss of \$16.1 million on  
3 revenues of \$18.5 million. Based on the foregoing, Staff believes that Applicant has sufficient  
4 financial resources to be allowed to charge customers any prepayments, advances, or deposits without  
5 posting a performance bond to cover such customer prepayments, advances, or deposits.

6 6. Staff recommended approval of the application subject to the following conditions,  
7 that:

8 (a) The Applicant shall comply with all Commission rules, orders, and other  
9 requirements relevant to the provision of intrastate telecommunications service;

10 (b) The Applicant shall maintain its accounts and records as required by the  
11 Commission;

12 (c) The Applicant shall file with the Commission all financial and other reports  
13 that the Commission may require, and in a form and at such times as the Commission  
may designate;

14 (d) The Applicant shall maintain on file with the Commission all current tariffs  
15 and rates, and any service standards that the Commission may require;

16 (e) The Applicant shall comply with the Commission's rules and modify its tariffs  
17 to conform to these rules if it is determined that there is a conflict between the  
Applicant's tariffs and the Commission's rules;

18 (f) The Applicant shall cooperate with Commission investigations of customer  
19 complaints;

20 (g) The Applicant shall participate in and contribute to a universal service fund, as  
21 required by the Commission;

22 (h) The Applicant shall notify the Commission immediately upon changes to the  
Applicant's address or telephone number;

23 (i) The Applicant's intrastate interexchange service offerings should be classified  
24 as competitive pursuant to A.A.C. R14-2-1108;

25 (j) The rates proposed by the Applicant in its most recently filed tariffs should be  
26 approved on an interim basis. The maximum rates for these services should be the  
27 maximum rates proposed by the Applicant in its proposed tariffs. The minimum rates  
28 for the Applicant's competitive services should be the Applicant's total service long  
run incremental costs of providing those services; and

1 (k) In the event that the Applicant states only one rate in its proposed tariff for a  
2 competitive service, the rate stated should be the effective (actual) price to be charged  
3 for the service as well as the service's maximum rate.

4 7. Staff also recommended approval of Novo Networks Metro Services, Inc.'s  
5 application subject to the following conditions:

6 (a) That the Applicant file conforming tariffs within 30 days of an Order in this  
7 matter, and in accordance with the Decision;

8 (b) That the Applicant file in this Docket, within 18 months of the date it first  
9 provides service following certification, sufficient information for Staff  
10 analysis and recommendation for a fair value finding, as well as for an analysis  
11 and recommendation for permanent tariff approval. This information must  
12 include, at a minimum, the following:

13 1. A dollar amount representing the total revenue for the first twelve months  
14 of telecommunications service provided to Arizona customers by Novo  
15 Networks Metro Services, Inc. following certification, adjusted to reflect  
16 the maximum rates that the Applicant has requested in its tariff. This  
17 adjusted total revenue figure could be calculated as the number of units  
18 sold for all services offered times the maximum charge per unit.

19 2. The total actual operating expenses for the first twelve months of  
20 telecommunications service provided to Arizona customers by the  
21 Applicant following certification.

22 3. The value of all assets, listed by major category, including a description of  
23 the assets, used for the first twelve months of telecommunications services  
24 provided to Arizona customers by the Applicant following certification.  
25 Assets are not limited to plant and equipment. Items such as office  
26 equipment and office supplies should be included in this list.

27 (c) Novo Networks Metro Services, Inc.'s failure to meet the condition to timely  
28 file sufficient information for a fair value finding and analysis and  
recommendation of permanent tariffs shall result in the expiration of the  
Certificate of Convenience and Necessity and of the tariffs.

8. The Staff Report also stated that Applicant has no market power and the  
reasonableness of its rates would be evaluated in a market with numerous competitors.

9. On April 3, 2001, a Procedural Order was issued requiring exceptions to the Staff  
Report or a request that a hearing be set, to be filed by July 6, 2001. No exceptions were filed to the  
Staff Report, nor did any party request that a hearing be set.

10. On April 25, 2001, Novo filed Affidavits of Publication indicating compliance with

1 the Commission's notice requirements.

2 11. On August 29, 2000, the Arizona Court issued its Opinion in US WEST  
3 Communications, Inc. v. Arizona Corporation Commission, 1 CA-CV 98-0672, holding that "the  
4 Arizona Constitution requires the Commission to determine fair value rate bases for all public service  
5 corporations in Arizona prior to setting their rates and charges."

6 12. On October 26, 2000, the Commission filed a Petition for Review to the Supreme  
7 Court.

8 13. On February 13, 2001, the Commission's Petition was granted.

9 **CONCLUSIONS OF LAW**

10 1. Applicant is a public service corporation within the meaning of Article XV of the  
11 Arizona Constitution and A.R.S. §§ 40-281 and 40-282.

12 2. The Commission has jurisdiction over Applicant and the subject matter of the  
13 application.

14 3. Notice of the application was given in accordance with the law.

15 4. Applicant's provision of resold interexchange telecommunications services is in the  
16 public interest.

17 5. Applicant is a fit and proper entity to receive a Certificate for providing competitive  
18 resold interexchange telecommunications services in Arizona.

19 6. Staff's recommendations in Findings of Fact No. 6 and 7 are reasonable and should be  
20 adopted.

21 **ORDER**

22 IT IS THEREFORE ORDERED that the application of Novo Networks Metro Services, Inc.  
23 for a Certificate of Convenience and Necessity for authority to provide competitive resold  
24 interexchange telecommunications services, except local exchange services, is hereby granted.

25 IT IS FURTHER ORDERED that Novo Networks Metro Services, Inc. shall comply with  
26 Staff's recommendations as set forth in Findings of Fact Nos. 6 and 7.




1 IT IS FURTHER ORDERED that within 30 days of the effective date of this Decision, Novo
