On September 14, 2001, Main Street Telephone Company ("Main Street") filed a request (attached) for an extension of time to file its final tariff pursuant to Decision No. 63907.

Main Street acknowledged that the Arizona Corporation Commission required it to file its tariff within 30 days of the effective date of Decision No. 63907. According to Decision No. 63907, the required filing date was September 5, 2001. Main Street filed its final tariff on September 7, 2001. As a result, Main Street requests an extension of time to comply with Decision No. 63907. Staff finds Main Street's request for an extension to be reasonable in order to re-instate the CC&N.

Staff recommends that Main Street be granted an extension to file their final tariff as ordered in Decision No. 63907. Also, Staff recommends that the extension of time should be the same day as the effective date of the order granting this extension request and that all-remaining provisions of Decision No. 63907 remain in full force and effect.
