PROCEDURAL ORDER

BY THE COMMISSION:

On August 6, 2001, the Arizona Corporation Commission ("Commission") issued Decision No. 63907 which granted Main Street Telephone Co. ("Main Street") a Certificate of Convenience and Necessity ("CC&N") to provide competitive telecommunications services within the State of the Arizona.

Pursuant to Decision No. 63907, Main Street was ordered to submit its final tariff within 30 days of the Decision.

On September 10, 2001, Main Street filed its final tariff.

On September 14, 2001, Main Street filed a request for an extension to submit its final tariff ("Request") to comply with Decision No. 63907.

On September 18, 2001, Staff filed a memorandum stating it had no objection to this request.

IT IS THEREFORE ORDERED that Main Street's request for an extension is hereby granted and its September 14, 2001 filing satisfies the filing requirements in Decision No. 63907.
