PROCEDURAL ORDER

10 **BY THE COMMISSION:**

11 On August 6, 2001, the Arizona Corporation Commission ("Commission") issued Decision
12 No. 63908 which granted authority to Local Telcom Holdings, LLC, d/b/a Transpoint
13 Communications ("LTH") to provide competitive resold interexchange telecommunications services
14 in Arizona, except local exchange services.

15 Pursuant to Decision No. 63908, LTH was ordered to, among other things, file conforming
16 tariffs within 30 days of the date of the Decision.

17 On September 7, 2001, LTH filed the conforming tariffs and requested it be granted an
18 extension to that date to comply with this requirement.

19 Staff has no objections to the request.

20 IT IS THEREFORE ORDERED that the deadline for Local Telcom Holdings, LLC, d/b/a
21 Transpoint Communications to file conforming tariffs is hereby extended to September 7, 2001.
