PROCEDURAL ORDER

10 **BY THE COMMISSION:**

11 On February 20, 2001, Affordable Voice Communications, Inc. ("AVCI") submitted to
12 Docket Control of the Arizona Corporation Commission ("Commission") an application for a
13 Certificate of Convenience and Necessity ("Certificate") to provide competitive resold interexchange
14 telecommunications services within the State of Arizona.

15 Decision No. 63910 (August 6, 2001) approved the application and required AVCI to comply
16 with various actions by October 1, 2001.

17 On September 13, 2001, ACVI filed a Request for an Extension of time to Comply with
18 Decision No. 63448. ACVI states that it is negotiating with a new underlying IXC to replace Touch
19 America and expect to complete this Agreement by October 1, 2001.

20 On September 18, 2001, Staff indicated that it has no objection to this request.


