PROCEDURAL ORDER

BY THE COMMISSION:

On February 20, 2001, Affordable Voice Communications, Inc. ("AVCI") submitted to Docket Control of the Arizona Corporation Commission ("Commission") an application for a Certificate of Convenience and Necessity ("Certificate") to provide competitive resold interexchange telecommunications services within the State of Arizona.

Decision No. 63910 (August 6, 2001) approved the application and required AVCI to comply with various conditions by October 1, 2001.

On October 22, 2001, ACVI filed a Request for an Extension of time to Comply with Decision No. 63448.

On January 23, 2002, Staff indicated that it has no objection to a 45-day extension.

IT IS THEREFORE ORDERED that Affordable Voice Communications, Inc. shall comply with all conditions as stated in Decision No. 63910 no later than August 6, 2002 or 30 days prior to to providing service in Arizona, whichever occurs first. No additional extensions will be granted and failure to comply with the above-stated conditions will result in voidance of Affordable Voice Communications, Inc.'s CC&N without further order of the Commission.


