**PROCEDURAL ORDER**

**BY THE COMMISSION:**

11 On May 24, 2000, Enkido, Inc. ("Applicant" or "Enkido") submitted to Docket Control of the  
12 Arizona Corporation Commission ("Commission") an application for a Certificate of Convenience  
13 and Necessity ("Certificate") to provide competitive facilities-based and resold local exchange,  
14 exchange access, and interexchange telecommunications services statewide.

15 On February 20, 2001, a Procedural Order was issued setting the matter for hearing on May 9,  
16 2001.

17 On May 9, 2001, a hearing was held in this matter. At the hearing Staff indicated that it was  
18 amending some of its recommendations. Enkido indicated that it would like additional time to  
19 respond. In addition, Enkido has not published notice of its application and would like additional  
20 time to publish notice.

21 IT IS THEREFORE ORDERED that Enkido shall file a Response to Staff's recommendations  
22 by **May 21, 2001**.

23 IT IS FURTHER ORDERED that Staff shall file a Reply to Enkido's Response by **May 31,**  
24 **2001**.


25 IT IS FURTHER ORDERED that Applicant shall publish notice of its filing, as stated below,  
26 in newspapers in every county in Arizona in which Applicant desires to provide service and shall file  
27 Affidavits of Publication with the Commission no later than **June 15, 2001**.


