EXHIBIT A

Directories and Directory Assistance Listings

The Commission requires that EPGN submit a plan to have its customers' telephone numbers included in the incumbent's Directories and Directory Assistance Databases.

EPGN respectfully submits that it will not initially offer dial tone services to end-user customers, concentrating instead on the provision of services on a wholesale basis to other carriers. As a result, EPGN will not at this time seek to obtain number blocks, nor will it have customers obtaining numbers through it.

At such time as EPGN may offer dial tone services (and therefore telephone numbers) to end-user customers, EPGN will contract with Qwest, Southwestern Bell Telephone, Citizen's, CenturyTel and any other appropriate incumbent carriers to have its customers included in such carrier's Directories.

EXHIBIT B

Access to 911 Services

The Commission requires that EPGN certify, for the areas in which it intends to provide service, that all issues associated with the provision of 911 services have been resolved with the appropriate emergency services providers for such areas within 30 days of the effective date of the Commission's decision.

EPGN respectfully submits that it will not initially offer dial tone services to end-user customers, concentrating instead on the provision of services on a wholesale basis to other carriers. As a result, EPGN respectfully submits that the provision of 911 services is not applicable to it at this time. At such time as EPGN may offer dial tone services to end-user customers, EPGN will contact the appropriate providers of emergency services in its service areas and ensure that its end-user customers are able to access all 911 emergency services.
