**MOTION FOR LEAVE TO INTERVENE**

Pursuant to Rule 14-3-105, Arizona Administrative Code,  
U S WEST Communications, Inc. ("USWC"), applies to this Commission  
for an order granting leave to intervene in the above-captioned  
proceeding.

The Commission should grant USWC leave to intervene in this  
matter because USWC is directly and substantially affected by  
these proceedings. Americas.com, Incorporated ("Americas.com") is  
seeking a Certificate of Convenience and Necessity to provide  
local telecommunications services within the State of Arizona.  
For many years, USWC exclusively provided these services within  
the State of Arizona. As a result, Americas.com will be required  
to interconnect with USWC, and the two telecommunications  
companies will have to provide services to each other if the  
Certificate is granted. Under these circumstances, USWC clearly  
has a substantial and direct interest in the outcome of  
Americas.com's application.

Further, USWC's participation in the proceeding will not


