MCI, Inc. ("MCI") files the attached late-filed exhibit, which shows the mass market UNE-P (and QPP for Arizona) line counts, both nationally and for Arizona, for MCImetro Access Transmission Services LLC before and after the publicized events related to the WorldCom, Inc. bankruptcy. This exhibit is provided in response to

1 questions by Judge Nodes and Commissioner Spitzer on the effect of the bad publicity
2 generated by the events related to the WorldCom bankruptcy on the decline of MCI's mass
3 market business.

5 MCI is submitting this information as a late-filed exhibit because Mr. Beach
6 testified that he believed that the line counts actually increased after the July, 2002
7 bankruptcy filing and only began decreasing later as a result of several factors unrelated to
8 the bankruptcy, including the Bell operating companies being allowed to provide
9 interLATA long distance services in general, Qwest's entry into long distance into
10 Arizona specifically, and the enactment of federal and state "do not call" legislation. This
11 exhibit supports Mr. Beach's beliefs.

13 MCI has consulted with Staff about this exhibit and its contents and is authorized to
14 state that Staff has no objection to this exhibit or it being late-filed.
