On July 14, 2005, Administrative Law Judge Marc Stern filed a Procedural Order in this consolidated docket. In the Procedural Order, Staff was ordered to "review the late-filed exhibit by Sunrise Utilities, LLC ("Sunrise", or "the Company"), and shall file verification that the requests for water and wastewater of Sunrise correlate with the recently filed legal descriptions and fall within the areas sought to be certificated herein." Staff was ordered to file its verification not later than July 29, 2005.





On July 29, 2005, Staff filed its verification. On September 2, 2005, an additional late-filed letter from Sunrise was docketed. This letter added requests for service which had been had been inadvertently omitted from Sunrise's July 26, 2005 correspondence with Staff upon which Staff's July 29, 2005 memorandum was based.

On September 6, 2005, another Procedural Order was issued which ordered that "Staff shall review the late-filed exhibit dated September 2, 2005, by Sunrise Utilities, LLC and shall file verification that the requests for water and wastewater of [sic] service correlate with the most recently filed legal descriptions and fall within the areas sought to be certificated herein."

Attached are maps and legal descriptions of the most current version of Sunrise's requests for service and service area requested. Staff confirms that all the requests for service are within the service territory requested.
