## EMERGENCY OPERATIONS PLAN

### 1 Loss of source of the water supply

- a.) If the source water supply stops it would most likely be due to well pump failure. All efforts should be made to restore well pumping operation as soon as possible.
- b.) If well pump operation cannot be restored in a timely fashion prior to water storage tank depletion, then water shall be hauled in a disinfected tank on hand in the area from the Virgin Mt. Estates Water system ( Controlled by the system operator), Biasi Water Co. or other A.D.E.Q. approved sources.

### 2.) Loss of supply due to major component failure or structural collapse.

- a.) If failure occurs from storage tanks or any other structural component, isolate defective tank or component and, repair if possible and get back on line.

### 3.) Damage to power supply equipment and loss of power?

- a.) Power supply loss will be supplemented with a back up generator.
- b.) Power feeder line damage will be repaired by those skilled and responsible to do so.

### 4.) Contamination of distribution system water due to backflow?

- a.) It is the policy of the company to install or cause to be installed approved double check valve back flow prevention devices at potential contamination points such as R.V. connections. These will be tested on an annual basis.
- b.) Any back flow prevention devices found to be defective will be repaired immediately by the same certified testing company.
- c.) As distribution lines are installed, testing points will be established. Testing point #1 will be the water plant.
- d.) If contamination is found in the system, the source will be identified and eliminated. Then appropriate flushing, disinfection and testing will be done.
- e.) Water shall be continually tested as Prescribed By A.D.E.Q.

### 5.) Collapse of reservoirs, reservoir roof or pump house structure

- a.) Any collapse of reservoir or the roof will be remedied by isolating the damaged component, repairing or replacing it and then disinfecting it, testing it and bringing back on line.

- b.) Any significant structural defect in the pump house will be repaired in a timely manner as to not potentially interrupt water service.

6.) Breaks in transmission or distribution lines.

- a.) After any repair, flushing, disinfection and sampling will be done.
- b.) All valves in the system will be inspected and operated once a year.
- c.) A log will be kept of when the inspection was done and by whom.
- d.) Earth moving and other equipment will be kept on site or nearby for any maintenance or repairs.
- e.) A sufficient amount of basic spare parts and tools shall be stored and or on hand to make repairs.


7.) Chemical or microbiological contamination of water supply?

- a.) If any microbiological contamination of the water supply occurs, the source will be eliminated, the system will then be flushed, disinfected and then tested. The target chlorine residual will be .2 parts per million to be maintained in the event of a microbiological contamination event.
- b.) If chemical contamination occurs, the source will be identified and eliminated. Then, the system will be flushed and tested as appropriate.




