21 this matter, number W-02450A-04-837 (the "Hassayampa Ranch" matter).


22 1. On October 3, 2005, Sierra Negra Ranch filed Applications to Intervene in
23 docket numbers W-02450A-05-0430 and W-02450A-04-0837. Sierra Negra Ranch is a
24 landowner directly affected by the Corporation Commission's determination in matter
25 number W-02450A-05-0430, a request for a transfer of a Certificate of Convenience
26 and Necessity ("CC&N") from the West Phoenix Water Company to the Water Utility
of Greater Tonopah (the "West Phoenix Water Company matter"). The Staff Report on
file in the West Phoenix Water Company case incorporated by reference the same
conditions regarding Water Utility of Greater Tonopah's multiple water systems that
Staff recommended in this matter in its August 2, 2005 Staff Report, making continued

1 consideration of those conditions in this matter of direct interest to Sierra Negra Ranch.

2 2. Sierra Negra Ranch has learned that, on September 30, 2005, Staff filed in
3 this matter an Amended Staff Report with revised recommended conditions. Sierra
4 Negra Ranch will therefore address its remaining concerns in the West Phoenix Water
5 Company case.
