
APPLICATION FOR EXTENSION

Administrative Law Judge Rodda established a briefing scheduled that required the parties to file an initial brief on October 7, 2005, and reply briefs on October 21, 2005 (*see* Transcript of Proceedings, p. 455). Subsequently, Level 3 Communications and Qwest Communications commenced settlement negotiations. As a result, Level 3 Communications and Qwest Communications request that the briefing schedule be extended for forty-five (45) days such that the initial briefs will be due on November 18,

1 2005 and reply briefs due on December 2, 2005. The parties previously agreed to extend
2 the 270 day deadline until January 31, 2006, but now agree to extend that deadline until
3 March 31, 2006.
