BY THE COMMISSION:

On January 10, 2000, the City of Flagstaff, Arizona ("City") submitted to the Arizona Corporation Commission ("Commission") an application requesting the closure of two existing spur track crossings of the Burlington Northern and Santa Fe Railway Company ("Railroad") on Huntington Drive, 300 and 1300 feet east of Enterprise Road in Flagstaff, Arizona at AAR/Dot No. 25-143-U and No. 25-145-H. ("Application"). The City requested approval to close the crossings on behalf of the Railroad because all service has been terminated and the crossings have been removed from service. The Application was filed with Docket Control on January 19, 2000.

On February 4, 2000, by Procedural Order, the Application was set for a hearing and the City was ordered to notify any interested parties of the Application and the hearing.

On February 14, 2000, the City filed certification that notice had been provided pursuant to the terms of the Procedural Order.

On February 24, 2000, a full public hearing was held before a duly authorized Hearing Officer of the Commission at its offices in Phoenix, Arizona. At the conclusion of the hearing, the matter

1 was taken under advisement pending submission of a Recommended Opinion and Order to the
2 Commission.

4 Having considered the entire record herein and being fully advised in the premises, the
5 Commission finds, concludes, and orders that:

6 **FINDINGS OF FACT**

- 7 1. On January 19, 2000, the City filed an Application in which it requested approval for
- 8 closure of two existing spur track crossings of the Railroad on Huntington Drive, 300 and 1300 feet
- 9 east of Enterprise Road in the City at AAR/Dot No. 25-143-U and No. 25-145-H.
- 10 2. On February 11, 2000, the City provided notice by registered U.S. mail of the
- 11 Application and hearing thereon.
- 12 3. A hearing was held as scheduled on February 24, 2000.
- 13 4. The Application was filed because all service has been terminated and the crossings
- 14 have been removed from service.
- 15 5. Staff testified that the closures as requested in the Application are proper.
- 16 6. Staff has recommended that the Application be approved.

17 **CONCLUSIONS OF LAW**

- 18 1. The Commission has jurisdiction over the parties and over the subject matter of the
- 19 Application pursuant to Article XV of the Arizona Constitution and A.R.S. §§ 40-252, 40-336, and
- 20 40-337.
- 21 2. Notice of the Application was provided in accordance with the law.
- 22 3. The closure of the crossings is in the public interest.
- 23 4. The Application should be approved as recommended by Staff.

24 **ORDER**


25 IT IS THEREFORE ORDERED that the City of Flagstaff's Application is hereby approved.
