ORDER

BY THE COMMISSION:

Having considered the entire record herein and being fully advised in the premises, the Arizona Corporation Commission ("Commission") finds, concludes, and orders that:

FINDINGS OF FACT

1. On December 9, 1999, Laundry World, Inc. ("Applicant") filed with the Commission an application for a Certificate of Convenience and Necessity ("Certificate") to provide customer-owned pay telephone ("COPT") service in the State of Arizona.
2. In Decision No. 55817 (December 10, 1987), the Commission found that COPT providers were public service corporations subject to the jurisdiction of the Commission.
3. The Commission in Decision No. 57797 (April 8, 1992) adopted A.A.C. R14-2-901 through R14-2-909 to regulate COPT providers.
4. In Decision No. 58535 (February 14, 1994), the Commission adopted a Generic Tariff that establishes rates and minimum service standards applicable to COPT service.
5. Pursuant to A.R.S. § 40-282, the Commission may issue Decisions regarding COPT Certificates without a hearing.
6. Applicant has requested that a Certificate be granted pursuant to A.A.C. R14-2-905, and has indicated that it will provide COPT service pursuant to the rates, terms and conditions

1 specified in the Generic COPT Tariff.

2 7. Applicant is a corporation.

3 8. Applicant does not presently provide COPT services in Arizona.

4 9. On December 16, 1999, Staff filed a Staff Recommendation, recommending approval
5 of Applicant's application without a hearing. Staff stated that Applicant has not submitted a copy of
6 its customer information placard that meets the terms of the Generic COPT Tariff.

7 10. Staff further recommended that the Commission condition approval of the application
8 on Applicant filing a copy of its customer information placard with Staff for approval prior to it
9 providing service.

10 CONCLUSIONS OF LAW

11 1. Applicant is a public service corporation within the meaning of Article XV of the
12 Arizona Constitution and A.R.S. §§ 40-281 and 40-282.

13 2. The Commission has jurisdiction over Applicant and the subject matter of the
14 application.

15 3. Notice of the application was given in accordance with the law.

16 4. With the conditions stated below, the provision of COPT service in Arizona by
17 Applicant is in the public interest.

18 5. Applicant is a fit and proper entity to receive a Certificate for providing COPT service
19 in Arizona.

20 ORDER

21 IT IS THEREFORE ORDERED that the application of Laundry World, Inc. for a Certificate
22 of Convenience and Necessity for authority to provide customer-owned pay telephone service in
23 Arizona shall be, and the same is, hereby granted, conditioned upon Applicant filing a customer
24 information placard approved by the Director of the Utilities Division for compliance with the
25 requirements of the Generic COPT Tariff within sixty days of the effective date of this Decision.

26 IT IS FURTHER ORDERED that if Laundry World, Inc. fails to timely file an approved
27 customer information placard, the application shall be denied without further Order of this



Commission, and Staff shall notify the local exchange company that provides public access line service to Applicant's pay telephones, if any, pursuant to A.A.C. R14-2-903.C, so that any public access lines held by Applicant are disconnected.


IT IS FURTHER ORDERED that Laundry World, Inc. shall comply with the terms of the Generic COPT Tariff, unless otherwise ordered by the Commission, pursuant to A.A.C. R14-2-906.

IT IS FURTHER ORDERED that this Decision shall become effective immediately.
