12 FINDINGS OF FACT

13 1. NYNEX Long Distance Company d/b/a Bell Atlantic Long Distance (NLD) is
14 certificated to provide intrastate telecommunications service as a public service corporation in the
15 State of Arizona.

16 2. On August 30, 1999, NLD filed tariff revisions to withdraw all rates and services from
17 its tariff currently on file with the Commission:

3. NLD proposes to discontinue service to its Arizona customers (approximately 240) while retaining authority to offer service in Arizona. NLD will reenter the Arizona market later this year with new products designed for business and data communications customers.

4. Exiting customers who will no longer have NLD service have been given 60 days notice to find a new carrier. NLD has sent two letters of notification to its customers.

5. NLD is requesting that these revisions become effective on October 22, 1999.

6. Staff has recommended approval of the filing.

CONCLUSIONS OF LAW

1. NLD is certificated to provide intrastate telecommunications service as a public service corporation in the State of Arizona.

2. The Commission has jurisdiction over NLD and over the subject matter of the application.

3. The Commission, having reviewed the tariff pages (copies of which are contained in the Commission's tariff files) and Staff's Memorandum dated September 8, 1999, concludes that it is reasonable to approve the proposed tariff revisions.

IT IS FURTHER ORDERED that this Decision shall become effective immediately.




