



BY THE COMMISSION:

FINDINGS OF FACT

1. AT&T Communications of the Mountain States, Inc. (AT&T) is certificated to provide telephone service as a public service corporation in the State of Arizona.

2. On September 2, 1999, AT&T submitted revisions to its Telecommunications Services Tariff:

Telecommunications Services Tariff
Section 5, Page 9, Release 1

Telecommunications Services Price List
Section 5, Page 2, Release 6

2. These revisions introduce AT&T Seven Sense Plan.

3. AT&T Seven Sense Plan is a residential long distance calling plan which is already effective for AT&T's interstate customers. This filing introduces an intrastate add-on to the interstate plan.

4. The intrastate AT&T Seven Sense Plan has maximum rates of \$0.30 per minute for interLATA calls and \$0.27 per minute for intraLATA calls.

5. The actual rates introduced with this filing are \$0.15 per minute for interLATA calls and \$0.09 per minute for intraLATA calls.




THEREFORE, IT IS ORDERED that this filing be and hereby is approved.
