



ADMINISTRATION DOCKET

On July 22, 2005, Arizona Public Service Company ("APS") filed an application with the Arizona Corporation Commission for approval of a power supply adjustor ("PSA") surcharge of \$.001770 per kWh. According to the application, the PSA surcharge is necessary to collect \$100 million of unrecovered fuel and purchased power costs. The Commission has determined that a hearing on this application, as well as on the PSA Plan of Administration submitted as a result of the Commission's Decision in APS' recent rate case, should be held.

The Commission will hold a hearing on this matter beginning **October 26, 2005** at 10:00 a.m. at the Commission's offices, 1200 West Washington, Phoenix, Arizona. Public comments will be taken on the first day of the hearing. Written public comments may be submitted via email (visit <http://www.cc.state.az.us/utility/cons/index.htm> for instructions), or by mailing a letter referencing Docket Numbers E-01345A-03-0437 and E-01345A-05-0526 to: Arizona Corporation Commission, Consumer Services Section, 1200 West Washington, Phoenix, AZ 85007.

Copies of APS' surcharge application and the proposed PSA Plan of Administration are available at its office, 400 North 5th Street, Phoenix, Arizona, 602/250-3633, and the Commission's offices at 1200 West Washington, Phoenix, Arizona, for public inspection during regular business hours. Information about these dockets is also available at the Commission's website <http://www.cc.state.az.us/> and at APS' website aps.com.

The law provides for an open public hearing at which, under appropriate circumstances, interested parties may intervene. Intervention shall be permitted to any person entitled by law to intervene and having a direct and substantial interest in the matter. Persons desiring to intervene must file a written motion to intervene with the Commission, which motion should be sent to APS or its counsel and to all parties of record, and which, at the minimum, shall contain the following:

1. The name, address, and telephone number of the proposed intervenor and of any party upon whom service of documents is to be made if different than the intervenor.
2. A short statement of the proposed intervenor's interest in the proceeding (e.g., a customer, stockholder of APS, etc.).
3. A statement certifying that a copy of the motion to intervene has been mailed to APS or its counsel and to all parties of record in the case.

The granting of motions to intervene shall be governed by A.A.C. R14-3-105, except that all motions to intervene must be filed on or before October 14, 2005. For information about requesting intervention, visit the Arizona Corporation Commission's webpage at <http://www.cc.state.az.us/utility/forms/index.htm>. The granting of intervention, among other things, entitles a party to present sworn evidence at hearing and to cross-examine other witnesses. However, failure to intervene will not preclude any customer from appearing at the hearing and making a statement on such customer's own behalf.

The Commission does not discriminate on the basis of disability in admission to its public meetings.
