13 FINDINGS OF FACT

14 1. On April 5, 1999, Citizens Telecommunications Company of the White Mountains, Inc.  
15 (Citizens) filed an application for approval of an Agreement for Service Resale between Citizens and  
16 Arizona Dialtone, Inc. (AZ Dial). The term of the Agreement begins March 1, 1999 and will  
17 terminate on February 28, 2001. Renegotiations for a contract extension must take place between the  
18 parties no later than 120 days prior to expiration of the present agreement. The Agreement governs  
19 the terms and conditions under which Citizens will resell its services to AZ Dial.

20 2. The Telecommunications Act of 1996 (1996 Act) directed incumbent local exchange  
21 carriers to make their networks available for interconnection and resale by new entrants to the local  
22 exchange market. The 1996 Act provides for interconnection and resale agreements to be concluded  
23 by voluntary negotiation.

24 3. This Resale Agreement between Citizens and AZ Dial was voluntarily negotiated,  
25 without resort to arbitration.

26 4. Under the terms of the Agreement, Citizens will make certain local exchange services  
27 available to AZ Dial under the terms and conditions of the Agreement. Generally, Citizens services  
28 will be made available to AZ Dial for resale at a 12 percent discount.
