





BY THE COMMISSION:

18 Having considered the entire record herein and being fully advised in the premises, the
19 Arizona Corporation Commission ("Commission") finds, concludes, and orders that:

FINDINGS OF FACT

- 20 1. Gerry M. Navarro dba Navarro Phones ("Applicant") is a sole proprietorship that has a
21 Certificate of Convenience and Necessity ("Certificate") to provide customer-owned pay telephone
22 ("COPT") service in the State of Arizona pursuant to Decision No. 59618 (April 24, 1996).
- 23 2. On February 17, 1999, Applicant submitted to Docket Control an application for
24 approval of the cancellation of the Certificate. The application was docketed on February 19, 1999.
- 25 3. In Decision No. 55817 (December 10, 1987), the Commission found that COPT
26 providers were public service corporations subject to the jurisdiction of the Commission.
- 27 4. Decision No. 57797 (April 8, 1992) adopted A.A.C. R14-2-901 through R14-2-909 to
28 regulate COPT providers.
- 5. Decision No. 58535 (February 14, 1994) adopted a Generic Tariff that establishes
rates and minimum service standards applicable to COPT service.
- 6. Pursuant to A.R.S. § 40-282, the Commission may issue Decisions regarding COPT
Certificates without a hearing.
