BY THE COMMISSION:

FINDINGS OF FACT

1. On March 4, 1999, GTE California Incorporated (GTE) filed an application for approval of an agreement for service resale between GTE and DPI-Teleconnect, L.L.C. (DPI).
2. The term of the agreement is for two years, with automatic renewal for successive periods of one year.
3. The agreement governs the terms and conditions under which GTE will resell its services to DPI.
4. The Telecommunications Act of 1996 (1996 Act) directed incumbent local exchange carriers to make their networks available for interconnection and resale by new entrants to the local exchange market. The 1996 Act provided for interconnection and resale agreements to be concluded by voluntary agreement. This resale agreement between DPI and GTE was voluntarily negotiated, without resort to arbitration.
5. Under terms of the agreement, GTE will make certain local exchange services available to DPI at prices contained within the agreement and under the terms and conditions of the agreement. Generally, GTE's residential and business services will be made available to DPI for resale at an 11.9 percent discount.


ORDER
