13 FINDINGS OF FACT

14 1. CenturyTel of the Southwest, Inc. ("CenturyTel") is certified to provide intrastate
15 telecommunications service as a public service corporation in the State of Arizona.

16 2. On December 29, 2000, CenturyTel filed tariff revisions to offer Custom Local Area
17 Calling Service ("CLASS") features:

Section 18, Sheet Nos. 1-2, Release 2
Section 18, Sheet Nos. 3-8, Original

20 3. CenturyTel proposes to introduce the following CLASS features:

- 21 • Anonymous Call Rejection,
- 22 • Call Forward-Busy and Call Forward-No Answer,
- 23 • Call Forwarding-Remote Activation,
- 24 • Call Pickup,
- Call Return,
- Call Transfer,
- 25 • Call Waiting Deluxe and Call Waiting Display,
- 26 • Caller ID Blocking – Per Call and Caller ID Blocking – Per Line,
- Caller ID Name and Number and Caller ID Number Only,
- 27 • Cancel Call Waiting,
- Distinctive Ring,
- 28 • Home Intercom,

- Long Distance Alert,
- Make Set Busy,
- Repeat Dial,
- Selective Call Acceptance, Selective Call Forwarding, and Selective Call Rejection,
- Subscriber Activated Blocking/PIN, and
- Wake Up Service.

4. On January 9, 2001, CenturyTel submitted a letter in which it agreed to waive the thirty-day time limit within which the Commission must act.

5. CenturyTel has provided a copy of the information pamphlet that it intends to distribute to its customers. Staff has reviewed the filing and CenturyTel's proposed pamphlet. Staff has determined that the plan is similar to those approved for U S WEST Communications, Inc. (now known as Qwest Corporation) and several other Arizona Local Exchange Carriers. It includes bill inserts, the use of Market Message Lines on each customer's bill, individualized letters to unlisted and unpublished numbers, and individual letters to law enforcement, government, and domestic violence agencies.

6. Staff recommends approval of this filing.

CONCLUSIONS OF LAW

1. CenturyTel is an Arizona public service corporation within the meaning of Article XV, Section 2, of the Arizona Constitution.

2. The Commission has jurisdiction over CenturyTel and over the subject matter of the application.

3. The Commission, having reviewed the application and Staff's Memorandum dated August 17, 2001, concludes that the filing is reasonable, fair and equitable, and is therefore in the public interest.


THEREFORE, IT IS ORDERED that the filing be and hereby is approved.
