On January 17, 2001 SNIP Link, L.L.C. ("Company") filed an Application and Petition with the Arizona Corporation Commission (Commission) for a Certificate of Convenience and Necessity to provide private telecommunications services as an Interexchange Carrier ("Application"), throughout the State of Arizona, of the (ring and words specified in the Application filed with the Commission. The Company's Application is available for inspection during the regular business hours at the office of the Arizona Corporation Commission, in Phoenix, Arizona, at 1100 North Central Avenue, and at SNIP Link, L.L.C. in Perth Amboy, New Jersey, at 100-A Winbriar Drive.

Interested parties shall have twenty (20) days from the publication of this notice to file objections to the Application. The law provides for an open public hearing at which, under appropriate circumstances, interested parties may intervene. Intervention shall be permitted to any person permitted by law to intervene, and having a direct and substantial interest in this matter. Persons desiring to intervene must file a written motion to intervene with the Commission within twenty (20) days from the publication of this notice. This motion shall be sent to SNIP Link, L.L.C., its counsel, and to all parties of record, and, at the minimum, shall contain the following: the name, address and telephone number of the proposed intervenor and of any party upon whom service of documents is to be made, if different from the intervenor.

A short statement of the proposed intervenor's interest in the proceeding (e.g., a customer of SNIP Link, L.L.C. or shareholder of SNIP Link, L.L.C., a competitor, etc.).

A statement certifying that a copy of the Motion to Intervene has been mailed to SNIP Link, L.L.C. or its counsel, and to all parties of record in the case.

A.C.C. (A.C.C.) shall oversee the granting of motions to intervene. The granting of intervention, among other things, entitles a party to present sworn evidence at the hearing and to cross-examine other witnesses. However, failure to intervene will not preclude any interested person or entity from appearing at the hearing and making a statement on their own behalf.
