PROCEDURAL ORDER

BY THE COMMISSION:

On August 30, 2001, the Arizona Corporation Commission ("Commission") issued Decision No. 63994 which granted EZ Phone, Inc. d/b/a Home Phone, Inc. ("EZ Phone") a Certificate of Convenience and Necessity ("CC&N") to provide resold local exchange services within the State of the Arizona.

Pursuant to Decision No. 63994, EZ Phone was ordered to procure a performance bond equal to \$25,000 and file a copy of the bond within 90 days of the effective date of the Decision.

On January 3, 2002, EZ Phone filed proof of the bond.

On January 3, 2002, EZ Phone filed a request for an extension of time to comply with the Decision.

On February 4, 2002, Staff filed a memorandum stating it had no objection to this request.

IT IS THEREFORE ORDERED that EZ Phone, Inc.'s request for an extension is hereby granted and its January 3, 2002 filing satisfies the filing requirements in Decision No. 63994.


