On October 4, 2001, EZ Phone, Inc. ("EZ") submitted correspondence requesting an extension of time to comply with conditions in the decision granting EZ authority to provider resold interexchange telecommunications services (Decision No. 63994). EZ's CC&N was conditioned on the Company filing conforming tariffs within 30 days of the effective date of the Commission's Decision, and to notify the Compliance Section of the Utilities Division of the date that the Company will begin or has begun providing service to Arizona customers. EZ filed its tariffs after the 30 day requirement and its certificate was void without further order of the Commission. Therefore, EZ requires additional time to comply with the Decision. Staff has no objections to this request.


