PROCEDURAL ORDER

**BY THE COMMISSION:**

In Decision No. 63997 (August 30, 2001), ASC Telecom, Inc. dba Alternatel ("Applicant") was granted a Certificate of Convenience and Necessity ("Certificate") to provide resold interexchange telecommunications services, except local exchange services, with the State of Arizona.

On February 24, 2003, Applicant sent a document to the Commission which indicates Applicant was in compliance prior to the due date listed in Decision No. 63997. This document was not docketed, therefore, Staff was unaware of its existence until May, 2003.


On March 27, 2003, the Arizona Corporation Commission ("Commission") Utilities Division ("Staff") filed a letter indicating that the Certificate was void because the Applicant failed to comply with Decision No. 63997.

On May 8, 2003, Staff filed a memo explaining the confusion and stated Applicant has complied with Decision No. 63997. Therefore, Staff stated Applicant's Certificate is valid.


