1. A check of the United States Post Office for the current address or any relocation for the Respondent.


- 1 2. A check of the last known employment of the Respondent, for the past two years.

- 8 with or contractual relationship with the Respondent.
- 9 7. A check of law enforcement arrest and/or criminal records in all States for the
- 10 Respondent.
- 11 8. A check of the Arizona Department of Transportation, Motor Vehicle Department
- 12 records of the Respondent's last known address.
- 13 9. A check of all utility companies, which include water, sewer, cable TV, and electric in
- 14 the last know area of the Respondent's residences.
- 15 10. A check of the Maricopa County Assessor's Office for the Respondent.
- 16 11. A check of the Maricopa County Recorder's Office for the Respondent.
- 17 12. A check of the Maricopa County Superior Court for the Respondent.
