PROCEDURAL ORDER

BY THE COMMISSION:

On September 2, 2005, Betty Bingaman ("Complainant") filed with the Arizona Corporation Commission ("Commission") a formal complaint against Citizens Utilities Rural Company dba Frontier Citizens Utilities Rural ("Frontier").

On October 3, 2005, Frontier filed a response to the complaint.

Accordingly, a pre-hearing conference should be scheduled.

IT IS THEREFORE ORDERED that a **telephonic procedural conference** shall be scheduled on **November 15, 2005, at 8:15 a.m.** The call-in number is 602-542-9002.


IT IS FURTHER ORDERED that all parties must comply with Rule 33 (c) and (d) of the Rules of the Arizona Supreme Court with respect to practice of law and admission *pro hac vice*.

IT IS FURTHER ORDERED that withdrawal of representation must be made in compliance with A.A.C. R14-3-104(E) and Rule 1.16 of the Rules of Professional Conduct (under Rule 42 of the Arizona Supreme Court). Representation before the Commission includes the obligation to appear at all hearings and procedural conferences, as well as all Open Meetings for which the matter is scheduled for discussion, unless counsel has previously been granted permission to withdraw by the Administrative Law Judge or the Commission.

IT IS FURTHER ORDERED that the Ex Parte Rule (A.A.C. R14-3-113 - Unauthorized Communications) applies to this proceeding and shall remain in effect until the Commission's Decision in this matter is final and non-appeable.

1 IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend, or waive
2 any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.


