

**PUBLIC NOTICE OF AN APPLICATION FOR AN
EXTENSION OF ITS CERTIFICATE OF CONVENIENCE AND NECESSITY
BY JOHNSON UTILITIES, L.L.C.**

Johnson Utilities, L.L.C. has filed with the Arizona Corporation Commission ("Commission") an application for authority for an extension of its Certificate of Convenience and Necessity to provide water and wastewater services. Our records indicate that you are either currently a customer of Johnson Utilities, L.L.C. or a property owner in the proposed extension area. If the application is granted, Johnson Utilities, L.L.C. would be the exclusive provider of water and wastewater services to the proposed area. Johnson Utilities, L.L.C. will be required by the Commission to provide this service under the rates and charges and terms and conditions established by the Commission. The granting of the application would not necessarily prohibit an individual from providing service to themselves from individually owned facilities on their property. The application is available for inspection during regular business hours at the offices of the Commission located at 1200 West Washington Street, Phoenix, AZ. and at Johnson Utilities, L.L.C. located at 5230 E. Shea Blvd., Scottsdale, AZ.

The Commission will hold a hearing on this matter. As a property owner, or customer, you may be entitled to intervene in the proceeding. If you do not want to intervene, you may appear at the hearing and make a statement on your behalf. You may contact the Commission at the address and telephone number listed below for the date and time of the hearing and for more information on intervention. You may not receive any further notice of the proceeding unless requested by you.
