





BY THE COMMISSION:

FINDINGS OF FACT

1. On December 18, 1998, U S WEST Communications, Inc. (U S WEST) filed an application for approval of an Agreement for local wireline network interconnection and service resale between U S WEST and Intermedia Communications, Inc. (Intermedia).
2. The term of the Agreement starts at the date of Commission approval and lasts for three years. The Agreement will remain in effect after this time until a new agreement becomes effective among the parties. The parties agree to commence re-negotiation one year prior to the date of contract expiration.
3. The Agreement governs the terms and conditions for local interconnection, local resale, and the purchase of unbundled network elements.
4. The Telecommunications Act of 1996 (1996 Act) directed incumbent local exchange carriers to make their networks available for interconnection and resale by new entrants to the local exchange market. The 1996 Act provided for interconnection and resale agreements to be concluded by voluntary agreement.
5. This interconnection and resale Agreement between Intermedia and U S WEST was voluntarily negotiated, without resort to arbitration.


1 4. The Commission maintains jurisdiction over the subject matter of the Agreement and
2 Amendments thereof, to the extent permitted pursuant to the powers granted the Commission by the
3 Arizona Constitution, Statutes, Commission Rule, and the 1996 Act and the Rules promulgated
4 thereunder.

5 ORDER

6 THEREFORE, IT IS ORDERED that the Commission hereby approves the Interconnection
7 Agreement as filed by the parties on December 18, 1998.

8 IT IS FURTHER ORDERED that this Decision shall become effective immediately.
