PROCEDURAL ORDER

9 **BY THE COMMISSION:**

10 On October 26, 2005, the RHI and Yucatan Respondents filed a Motion to Reset Hearings
11 (“Motion”) in the above-captioned matter from November 8, 9 and 10 and December 1 and 2, 2005,
12 due to scheduling conflicts of counsel for RHI and Yucatan. Counsel for Mr. Kelly had no objection
13 to the Motion. Respondents suggested that the proceeding be rescheduled for the weeks of January
14 23 and 30, 2006, and that neither counsel for Mr. Kelly nor the Division had a conflict with the
15 alternate dates.

16 On October 27, 2005, the Division filed a response which objected to the matter being
17 rescheduled.

18 Under the circumstances, since the previous schedule appears to be inadequate to complete
19 the hearing, the hearing in the above-captioned proceeding should be rescheduled as requested to
20 allow for the orderly completion of the proceeding.

21 IT IS THEREFORE ORDERED that the **hearing** shall be continued from November 8, 9, 10,
22 December 1 and 2, 2005, to **January 23, 2006, at 9:30 a.m.**, at the Commission’s offices, 1200 West
23 Washington Street, Phoenix, Arizona.

24 IT IS FURTHER ORDERED that the parties shall also set aside **January 24, 25, 26, 27, 30,**
25 **31, February 1, 2, and 3, 2006, for additional days of hearing,** if necessary.
