PROCEDURAL ORDER

BY THE COMMISSION:

On March 11, 2005, Tacna Water Company ("Tacna") filed with the Arizona Corporation Commission ("Commission") an application for a rate increase.

On April 11, 2005, the Commission's Utilities Division ("Staff") filed a Letter of Deficiency.

On May 9, 2005, Tacna filed a supplement to its rate application in response to Staff's Letter of Deficiency.

On June 8, 2005, Staff filed a second Letter of Deficiency.

On July 25, 2005, Staff filed a Letter of Sufficiency classifying Tacna as a Class E utility.

On August 16, 2005, Staff filed a request to suspend the time clock indefinitely to allow Staff adequate time to obtain and review Tacna's data responses, stating that it would continue to process the application as quickly as possible, and that Tacna had no objection to Staff's request.

On August 25, 2005, by Procedural Order, the time clock was suspended indefinitely in the rate case proceeding.

On September 7, 2005, Tacna filed the above-captioned financing application.

On September 30, 2005, Staff filed a Motion to Consolidate the rate application and the financing application. Staff stated that the two matters are inextricably linked and that the outcome of the one application is dependent on the outcome of the other.

Staff's request is reasonable and should be granted.

1 IT IS THEREFORE ORDERED that the above-captioned applications are hereby
2 consolidated for purposes of hearing.

3 IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend, or waive
4 any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.


