**RESPONSE TO MOTION
FOR EXTENSION OF TIME**

Arizona Corporation Commission Staff ("Staff") hereby responds to the Motion for an Extension of Time filed by SBC Long Distance, LLC ("SBC") on October 25, 2005. In its Motion, SBC asks for an extension of time to comply with Decision No. 67827, which requires SBC to file, within 180 days of the effective date of the decision, proof that SBC is authorized to transact business in Arizona. SBC's Motion also asks for an acknowledgement that all other compliance items required by Decision No. 67827 have been met.

SBC's Motion describes the efforts that it has undertaken to obtain the necessary documents to complete the required filing. Under the circumstances described in the Motion, Staff does not object to a reasonable extension of time.

SBC's Motion also asks the Commission to acknowledge that SBC has satisfied all other compliance items set forth in Decision No. 67827. Staff's compliance review in this matter shows that SBC has no outstanding issues related to Decision No. 67827.


