PROCEDURAL ORDER

BY THE COMMISSION:

On April 4, 2003, Duncan Rural Services Corporation ("Duncan" or "Company") filed an application to incur debt with the Arizona Corporation Commission ("Commission").

On May 2, 2005, Duncan filed an application for a rate increase with the Commission.

In its rate application, Duncan requested that the finance and rate applications be consolidated.

On October 25, 2005, Commission Utilities Division Staff ("Staff") filed a Motion to Consolidate the two applications.

The two matters are inextricably linked and the outcome of one is dependent on the other. Administrative efficiency is enhanced through consolidation.


IT IS THEREFORE ORDERED that Dockets Nos. G-02528A-03-0205 and G-02528A-05-0314 shall be consolidated.

IT IS FURTHER ORDERED that the Ex Parte Rule (A.A.C. R14-3-113 - Unauthorized Communications) continues to apply to this proceeding and shall remain in effect until the Commission's Decision in this matter is final and non-appealable.
