18 **REQUEST FOR PROCEDURAL ORDER**

19 Arizona Corporation Commission staff ("Staff") hereby requests that the Administrative Law
20 Judge ("ALJ") issue a procedural order to govern further proceedings in Track B of the generic
21 electric restructuring matter.

22 In July and August, Staff hosted two separate two-day workshops to discuss the details of
23 developing a competitive solicitation process. Although Staff had originally planned to issue a Staff
24 Report by September 23, 2002, it became clear by the conclusion of the second workshop that that
25 date was no longer feasible.


26 Staff now intends to issue a draft Staff Report by October 25, 2002. Staff also believes that it
27 will be helpful to have an additional two-day workshop to allow parties to further comment upon the
28 process. Finally, Staff believes that it is appropriate to schedule a hearing at this time.
